International Finance Corporation Has Become A Shareholder of Century Sunshine

Hong Kong, 24 February 2014 - Century Sunshine Groups Holding Limited (the Company, stock code: 509.HK) announced today that the Subscription by International Finance Corporation (IFC), a member of the World Bank Group was completed in accordance with the terms and conditions of the Subscription Agreement set on 28 January 2014. 155,077,000 new Shares, representing approximately 5.63% of the total enlarged issued share capital of the Company as at the date of this announcement, have been issued and allotted by the Company to IFC, at the Subscription Price of HK\$0.75 per Subscription Share.

The proceeds from the Subscription have been satisfied by cash payment by IFC. The net proceed is estimated to be approximately HK\$114 million. The Company intends to utilise the entire net proceeds as general working capital of the Group.

Chi Wen Fu, Chairman and CEO of the Company said, "The success in the subscription has reflected Century Sunshine is an outstanding enterprise with sound corporate strength, alongside IFC's confidence in our solid business model and growth potentials. The placement strengthens not only the capital structure but also enhances the image of the Company to accelerate the pace of our development."

"IFC's investment in Century Sunshine will support the company's next stage of growth and help build a sustainable business model in its fertilizer and magnesium alloy businesses. Our investment will be used to increase the capacity of Century Sunshine's fertilizer business to enhance food security. IFC's investment will also support an expansion of the magnesium alloy business in an interior province of China, helping to create long-term jobs," said IFC Director Vipul Prakash.
